- Treat this pet humanely at all times
- Provide this pet with proper and adequate attention, food, water, housing/shelter, exercise, and grooming
- Provide health and medical care for this pet in the form of annual veterinary exams, vaccinations, and other preventative care and medications, as well as any emergency care needed
- House this pet indoors only
- Obey all applicable pet permitting and licensing and animal confinement laws
- Not sell this animal, abandon it, give it away, use it for fighting, use it for feeding, nor use it for experimentation
- Allow an H4P representative to visit my home on request within a reasonable amount of time to ensure the provisions of this contract are being adhered to and, in case of breach of this adoption contract, H4P shall have the right to demand immediate return of this pet
- (Cats Only) To NEVER declaw this animal

By signing this form, I/we acknowledge that all information on this form is true and correct. I/we understand that any misrepresentation of fact may result in H4P revoking adoption privileges from me/us. If my/our pet adoption is finalized and later H4P discovers the above information is not true or correct or that stipulations in the adoption contract are not being followed, H4P reserves the right to remove the adopted cat from my residence. The adoption application and adoption contract that I have submitted to H4P constitute the entire contract for the adoption of this pet, and no prior representations or agreements are of any force and effect unless incorporated herein.
